Living in Georgia I could have sat only for the Georgia Board of Court Reporting and been certified to only work there or I had the opportunity to sit for the National Board of Court Reporting. I chose nationally. So my NVRA (National Verbatim Reporters Assoc.) gives me the CVR and I automatically received my CCR once I submitted my test scores to Georgia. We study to speak/repeat into a mask at 200 - 225 words per minute. I also sat for a lengthy written test. I use a computer for notes, dictation and am training for Real Time now (just starting) which is A WHOLE different story ha ha!!!) I hope I have helped you out in some way?!
